

Approach to School Support and Improvement | Fall 2018



Vision for School Improvement

GaDOE is providing teaching resources, training, tools and tiered supports to help all schools and LEAs make progress in five areas: (1) instructional systems, (2) professional capacity, (3) leadership, (4) learning environments and (5) family and community engagement.

Key Strategies

PROGRESS UPDATES: During summer 2018, GaDOE led dozens of school improvement sessions on math and ELA instructional strategies (tied to GA standards) and effective leadership.

CHALLENGES: To provide comprehensive assistance to identified schools, GaDOE is working to support new Continuous Improvement Teams across SEA divisions and programs and in collaboration with regional service agencies .

TECHNICAL ASSISTANCE & COMPLIANCE:

- Templates and rubrics for improvement plans: Developed (a) school and district improvement plan templates, (b) needs assessment and rubric and (c) a rubric to evaluate LEA applications for federal funding
- Professional development: Curating a toolkit of resources, model lessons, etc. aligned to GaDOE's
 continuous improvement framework; organizing monthly school improvement institutes; and
 hosting meetings and webinars to review the application process and new resources
- Guidance: Developed materials to explain the process to educators, families and community
 members and provided guidance to LEAs on (a) ESSA regulations (b) the actions GaDOE will take to
 identify, support and intervene in CSI and TSI schools, (c) implementation strategies for TSI schools
 and (d) evidence-based strategies aligned to ESSA requirements
- Structures and processes: Developed or updated processes to (a) recruit, screen, select and
 evaluate external partners/providers, (b) provide feedback to LEAs on SI efforts, (c) work with
 regional service agencies to provide TA to LEAs and schools and (d) monitor progress

Key Updates

NEW POLICY/REGULATIONS: With exception of Tier 4 "turn-around" schools (chosen and overseen separate from GaDOE), SI requirements are based on federal law (no guiding state law).

NEW SEA PRACTICE: All identified schools and LEAs are assigned specialists, and all field staff are participating in National School Improvement certification; GaDOE provides opportunities for schools to apply for federal funds consolidation and requires LEAs to complete NAs for all identified schools.

Funding: Formula

As part of making allocations to districts on behalf of identified schools, GaDOE uses diagnostic assessments to provide feedback on local NAs and priorities.

GaDOE is investing in wraparound strategies, including \$1 million in funding for 16 wraparound specialists to support identified schools with non-academic factors affecting the whole child.
